Eng. Yousif Al Ali

*A Leadership Perspective on Water and Energy
Services in the Northern Emirates*

Eng. Yousif Al Ali, CEO of Etihad Water and Electricity (EtihadWE), plays a central role in advancing the evolution of utility services in the UAE, with a clear focus on sustainability, innovation, and national development. Since assuming the role in January 2023, his leadership has guided EtihadWE's shift towards a smarter, more future-ready operating model—aligned with the UAE's long-term sustainability and Net Zero by 2050 ambitions.

Leading Ambitious Utility Transformation

Under Eng. Yousif's stewardship, EtihadWE has spearheaded some of the region's most pioneering projects:

- **Naqa'a Reverse Osmosis Plant (2024):** This ground-breaking facility represents a major milestone in EtihadWE's transition to 100% reverse osmosis desalination, positioning the company as the only utility in the UAE whose desalination operations fully rely on RO technology. With a capacity of 150 million imperial gallons per day, the plant significantly reduces energy consumption and carbon footprint.
- **UAEV – Nation's First Government-Owned EV Charging Network (2024):** Recognizing the future of transport, Eng. Yousif supported the launch of UAEV as a joint initiative between EtihadWE and the Ministry of Energy and Infrastructure. The network has rapidly expanded, aiming for 1,000 by 2030. This initiative places EtihadWE at the forefront of



- UAE's green mobility revolution.
- **Non-Revenue Water Reduction Initiative (2024):** Leveraging advanced technologies like SmartBall acoustic leak detection and SCADA real-time monitoring, EtihadWE improved leak detection speed, substantially reducing water losses in support of the UAE's Water Security Strategy 2036.
- **Distributed Solar System Program (2024):** In partnership with the Ministry of Energy & Infrastructure, this pioneering program enables citizens to install rooftop solar systems and offset their energy

- **Agricultural Support via Reduced Tariffs (2024):** Offering preferential electricity tariffs and tailored water infrastructure for over 9,000 farms, this initiative enhances agricultural productivity while safeguarding groundwater resources.

Driving Innovation, Transparency, and Accountability

Eng. Yousif has introduced a culture of efficiency and empowerment at EtihadWE through several strategic initiatives:

- **Zero Bureaucracy Program:** EtihadWE has played a key role in advancing the UAE's Zero Bureaucracy agenda through a comprehensive institutional transformation. During the program's second phase, the company launched 60 initiatives and eliminated more than 2,100 procedures, while redesigning core services such as payment, reducing steps from nine to three and saving customers over 12 million steps annually. AI-enabled solutions, including an institutional large language model and an intelligent NOC robot, supported digital enhancements across most core services, raising digital channel adoption from around 60% in late 2024 to over 90% and increasing customer satisfaction from 78% to above 84%.
- **Environmental Monitoring Framework:** Implementing the company's first comprehensive sustainability measurement system, EtihadWE now uses smart meters, SCADA, and predictive hydraulic modelling to enhance visibility of environmental performance.
- **Circular Economy Leadership:** By managing significant volumes of waste responsibly in 2024 and advancing recycling programs, the company reflects his commitment to a resource-efficient future.

A Holistic Vision Extending Beyond Utilities

Eng. Yousif's leadership transcends infrastructure; he actively supports culture, education, and research:

1. He championed the establishment of the EtihadWE Museum, safeguarding the UAE's water and energy heritage and inspiring future generations.

3. He chairs strategic projects such as the Naqaa Desalination Plant and serves on multiple boards, contributing his expertise to national development initiatives.
